## NARRATIVE

Maplecrest Road is a north south arterial on Fort Wayne's north side. Maplecrest Road recently was extended south of Lake Avenue, over the Maumee River and railroad tracks, and now connects with Adams Center Road at the intersection of State Road 930. The section of Maplecrest Road between Lake Avenue and State Boulevard is currently under design and is expected to let next spring (2014). Once that section is complete, this section of Maplecrest Road between State Boulevard and Stellhorn Road will be the only portion that will be unimproved.

Maplecrest Road between Stellhorn Road and State Boulevard has inconsistent through lanes. The corridor is a "bottleneck" as there are only two primary travel lanes between State Boulevard and Trier Road, then three lanes between Trier Road and Stellhorn Road (two southbound and one northbound). The number of lane "drops" through this section creates safety issues as motorists take risks to overtake other vehicles prior to lanes ending. Crash frequencies on Maplecrest Road from the Stellhorn Road intersection to State Boulevard have been a problem under the current conditions. Corrective action is needed to mitigate current and future crashes and safety issues.

This project corridor is primarily residential with commercial and retail uses located at both the north and south terminuses of this corridor (Stellhorn Road intersection and State Boulevard intersection). A five lane section is proposed for the Stellhorn Road to State Boulevard section of Maplecrest Road. In addition to the roadway improvements, this project will also provide bicycle/pedestrian facilities with a sidewalk on one side and a trail along the other side of the roadway. The project area is defined as Maplecrest Road from just north of Stellhorn Road to just south of State Boulevard; on Stellhorn Road approximately 1300' east and west of Maplecrest Road; and on State Boulevard approximately 300' east and west of Maplecrest Road.

- Three of the religious facilities are adjacent to the project area. These facilities may be affected by the project and are listed below:

- Crosspointe Community Church - 6120 Stellhorn Rd (located in a shopping mall)

- The Georgetown Little League recreational facility is the only facility that is adjacent to the project area. It is located at 3732 Maplecrest Rd. This facility may be affected by the project.
- There is one crude oil pipeline owned by Tri-State Pipeline Properties that intersects the half mile radius along its northeastern edge. This pipeline is not within or near the project area so it will not be affected by the project.
- There are two managed lands located within the half mile radius but not adjacent to or within the project area. One is Mengerson Nature Preserve located at 5895 Stellhorn Rd. The other is Jehl Park which only has the northwest corner of its boundary touching the half mile radius. Neither of these properties will be affected by the project.

## Explanation:

- There is one NWI - line identified within the half mile radius but outside the project area. According to the map this wetland stream is located in a place that has been developed and is now covered by a parking lot. This feature will not be affected by the project.
- There are four features identified within or intersecting the half mile radius for the "Rivers and Streams" category. The Bullerman Drain, Trier, and Walke Branch are within the half mile radius but outside the project area so they will not be affected by the project. The Pierson Drain No. 2, which intersects the project area just north of Maplecrest Rd's intersection with State Blvd, will be affected by the project.
- There are seven wetland polygons located within or intersecting the half mile radius but only one touches the project area. The wetland intersecting the project area is located just north of Trier Road on the west side of Maplecrest. This wetland may not exist anymore since the location shown on the aerial map has been developed with housing. Further investigation is needed to determine if this wetland still exists. If it does still exist it may be affected by the project.
- Two features identified in the "Lakes" category were identified within or intersecting the half mile radius but are not located within or adjacent to the project area. They will not be affected by the project.
- The floodplain intersects with the half mile radius at three different locations. There is one area where the floodplain intersects with the project area. The floodplain crosses the Maplecrest Rd project area between approximately 600 ft north and $1,500 \mathrm{ft}$ north of the intersection of Maplecrest Rd and State Blvd. This may impact the project.
- *High Capacity Wells - To protect these features they are not identified in the water resource map due to their locational sensitivity. There were no high capacity wells found within a half mile radius of the project area.

## Explanation:

- There are two Industrial Waste Sites, one State Cleanup Site, one Voluntary Remediation Program site, and one Institutional Control Site located within or near the project area that may be affected by the project. They are all located near the intersection of Maplecrest Rd and Stellhorn Rd.
- The industrial Waste Sites are "Goodyear ASC \#6729" (Site ID No. IND984941633) and "Target Store T-134" (Site ID No. INRooo110734).
The State Cleanup Site is the "Target Store T-134" (Site ID No. 200402041).
- The Voluntary Remediation Program site is the "Target Store T-134" (Site ID No. 6040405).
- The Institutional Control Site is the "Kistners Family Marathon 2188 (IC VFC ID No. 26025325).
- There are seven Leaking Underground Storage Tanks within the half mile radius. Five of them are within or adjacent to the project area and may be affected by the project. One is located at the south end of the project area near the intersection of Maplecrest Rd and State Blvd and four of them are located at the north end of the project area near the intersection of Maplecrest Rd and Stellhorn Rd.
- There are 9 Underground Storage Tanks within the half mile radius. Seven of them are within or adjacent to the project area and may be affected by the project. One is located at the south end of the project area near the intersection of Maplecrest Rd and State Blvd and six of them are located at the north end of the project area near the intersection of Maplecrest Rd and Stellhorn Rd.
- *Infectious/Medical Waste Sites were not able to be confirmed or denied in the project area. More research is needed to determine if there are any in the $1 / 2$ mile radius of the project.


## Ecological Information

The Allen County listing of the Indiana Natural Heritage Data Center information on endangered, threatened, or rare (ETR) species and high quality natural communities is attached with ETR species highlighted. Due to the sensitive nature of identifying locations of threatened and endangered species, maps of these specific habitats are not provided.

Early Coordination is needed with IDNR and USFWS for this project. All documentation will need to be included in the environmental document.

## Cultural Resources

The items below represent all properties or bridges in Fort Wayne and Allen County that have obtained any type of historic designation. The types of historic designation are: Indiana Historic Bridge Inventory, Fort Wayne Local Historic Districts, the Indiana State Register of Historic Places, the National Register of Historic Places, the Historic American Buildings Survey, and National Historic Landmark. ## Explanation:

- Two properties were identified from the Fort Wayne Interim Report with a rating of "Contributing" for their historical significance and a third property with a rating of "Notable". These properties are listed below. None of these properties are within or adjacent to the project area. These properties will not be affected by the project. Please note that the Interim Report did not cover anything between Trier Rd and State Blvd. Discussions with the Fort Wayne Historic Preservation Commission and Architecture and Community Heritage (ARCH) of Fort Wayne indicated that nothing with historical significance was located along this section of the project area or half mile radius.

Further discussion with the Fort Wayne Historic Preservation Commission and Architecture and Community Heritage (ARCH) of Fort Wayne confirmed that there were no historic sites or districts that were within the $1 / 2$ mile area surrounding the project area.

## Pedestrian and Bus Stop Infrastructure

The project description identifies that a sidewalk will be installed on one side and a trail on the other side of Maplecrest Road from State Boulevard to Stellhorn Road. In addition, locations have been identified in the project area where pedestrian and bus stop infrastructure are needed to ensure that the pedestrian facilities are ADA compliant. All sidewalk and bus stop infrastructure must meet PROWAG (Proposed Accessibility Guidelines for Pedestrian Facilities in the Public Right of Way) standards. The list below corresponds with the attached map.

- 1) Bus stop pad installation at the existing bus stop on the south side of State Boulevard, west of the Maplecrest Road intersection.
- 2) Bus stop pad installation at the existing bus stop on the north side of State Boulevard, east of Maplecrest Road intersection. Sidewalk installation along the north side of State Boulevard from Maplecrest Road to the existing bus stop.
- 3) Sidewalk connection and crosswalk to the existing sidewalks on Brandy Chase Cove.
- 4) Bus stop pad installation at the existing bus stop on the east side of Maplecrest Road, north of the State Boulevard intersection.
- 5) Sidewalk connection to the existing sidewalk on Millhollow Lane.
- 6) Bus stop pad installation at the existing bus stop on the east side of Maplecrest Road, south of Alvarez Drive.
- 7) Sidewalk connection and crosswalk to the existing sidewalks on Alvarez Drive.
- 8) Sidewalk connection and crosswalk to the existing sidewalks on Pawawna Drive.
- 9) Sidewalk connection and crosswalk to the existing sidewalks on Vance Avenue.
- 10) Bus stop pad installation at the existing bus stop on the east side of Maplecrest Road, north of Pawawna Drive.
- 11) Bus stop pad installation at the existing bus stop on the east side of Maplecrest Road, south of Landmark Drive.
- 12) Sidewalk connection and crosswalk to the existing sidewalks on Landmark Drive.
- 13) Sidewalk connection and crosswalk to the existing sidewalks on Andro Run.
- 14) Bus stop pad installation at the existing bus stop on the east side of Maplecrest Road, south of Midfield Drive.
- 15) Sidewalk connection to the existing sidewalk on Brian Drive.
- 16) Bus stop pad installation at the existing bus stop on the east side of Maplecrest Road, south of Birchdale Drive.
- 17) Sidewalk (or trail) connection from Maplecrest Road (south side) to the existing sidewalk on Stellhorn Road, east of Oakhurst Drive.
- 18) Sidewalk (or trail) connection from Maplecrest Road (north side) to the signalized intersection of Northwood Plaza Shopping Center (entrance) on Stellhorn Road (connect to existing sidewalk on the west side of the entrance).
- 19) Bus stop pad installation at the existing bus stop on the north side of Stellhorn Road, east of the signalized intersection to Northwood Plaza Shopping Center.
- 20) Bus stop pad installation at the existing bus stop on the north side of Stellhorn Road, west of the Maplecrest Road intersection.
- 21) Sidewalk (or trail) connection from Maplecrest Road (south side) to the driveway of Advance Auto Parts and ProFed Credit Union.
- 22) Sidewalk (or trail) connection from Maplecrest Road (north side) to the far east entrance to Northwood Plaza Shopping Center on Stellhorn Road.
- 23) Sidewalk connection from Stellhorn Road to the entrance to Stellhorn Plaza Shopping Center on Maplecrest Road (west side).


## SUMMARY/RECOMMENDATIONS

INFRASTRUCTURE: A total of 21 items are identified in the Infrastructure section, however there are only five items that are adjacent to the project area and may be impacted by the project. These items are three churches (Maplewood Mennonite Church, Christ's Church, and Crosspointe Community Church); one school (Maplewood Mennonite Church); and one recreational facility (Georgetown Little League). Coordination with the identified churches, school and recreational facility should be undertaken as the project is developed to determine potential impacts.

WATER RESOURCES: A total of 14 items plus floodplain are identified in the Water Resources section. Of the 15 items it appears that only a few may be impacted by the project, most of the items are not adjacent to the project area. Potential impacts include the Pierson Drain No. 2; a wetland is identified in the area just north of Trier Road, additional research is needed to determine if it still exists. The last item is a section of floodplain, it is shown to be located north of the intersection of Maplecrest Road and State Blvd. A field visit will be required to document any potential impacts to the Water Resources. Additional coordination should also be
conducted with the Allen County Surveyor's Office, the City of Fort Wayne Water \& Sewer office and the Department of Planning Services.

MINING/MINERAL EXPLORATION: N/A
HAZMAT CONCERNS: Twenty-one items have been identified in this section. Many of the 21 items are adjacent to the construction area of this project. All of these items should be investigated to determine their potential impact to the project. Infectious/Medical Waste Sites were not confirmed or denied in the project area. More research is needed to determine if there are any in the $1 / 2$ mile radius of the project. Additional coordination should be conducted with the Indiana Department of Environmental Management (IDEM).

ECOLOGICAL INFORMATION: Coordination with the Indiana Department of Natural Resources (IDNR) and the U.S. Fish and Wildlife Service (USFWS) will be needed to determine the potential impact to any listed species and/or habitats may have on the project.

CULTURAL RESOURCES: Three properties were identified in the latest Interim Report. Further discussion with the Fort Wayne Historic Preservation Commission and Architecture and Community Heritage (ARCH) of Fort Wayne should be conducted to confirm that no additional properties have been identified from the time this report was developed.

PEDESTRIAN AND BUS STOP INFRASTURCTURE: Twenty-three locations have been identified that require new infrastructure. All facilities must meet PROWAG requirements.
