Introduction



1.0 Introduction

1.1 Plan Organization

The Decatur-Adams County Parks and Recreation 5-Year Master Park Plan is an outline of the goals and proposed actions of the City of Decatur and Adams County over the next five years. It was compiled through a collaboration of public input from town residents, special interest groups, local business owners, and the Decatur and Adams County Park Boards and Government. Park Plans are living documents and therefore, should be reviewed annually to ensure goals and proposed actions are still in line with the desires and capabilities of the Park Boards.

The Plan is a means to put the goals garnered through the planning process into an easy to follow and attainable action register that the local governments and residents may reference regarding additions or changes to the local Parks. The Park Boards should be contacted if there are any questions or concerns regarding the information presented in the Plan.

1.2 Definition of Planning Area

The planning area for the purposes of this Plan are Adams County political boundary and the City of Decatur within the County boundaries which has its own Park Board.




Figure 1: Decatur – Adams County Planning Area

Adams County is 217,600 acres (340 sq. miles) and home to nearly 36,000 residents. The Parks are used by residents residing within Decatur and Adams County as well as others living in surrounding communities and counties. The department shares maintenance duties with other agencies and schools as needed in an effort to maximize resources. Figure 1 below identifies the planning area.

1.3 Goals of the Plan

The goals of the Park Plan are:

- Improve the potential for funding opportunities in the future.
- Collaboration with the public, and state and federal agencies to establish realistic goals for the Park.
- Prioritize the needs and wants of the community to help guide the development of the park system and spend funds where they will have the biggest impact.
- Develop a capital improvement plan.

1.4 Park Board History

The Decatur-Adams County Parks and Recreation department (DACPR) is controlled by two separate boards: the Decatur Parks and Recreation Board and the Adams County Parks and Recreation Board. The Adams County/Decatur park boards maintain full statutory compliance with IC 36-10-3, and will provide detailed record of this compliance on request. The two Boards have a long history of sharing park duties, equipment, staff, and programs. The joint Parks and Recreation department was created in an effort provide adequate services, park maintenance, and staff for both jurisdictions. This partnership has enabled the two Boards to put funding and resources to better use, as well as, has allowed for residents to access quality parks and green spaces no matter where they reside within the County.

The Decatur Parks Board was first created in 1970 and was re-established in 1982 to meet the requirements of Indiana Code 36-10-3: General Park and Recreation Law. The Adams County Parks Board was created in 1967 and was re-established in 1982 for the same reasons as above. The boards are comprised of a diverse group of area residents representing varying education and vocational backgrounds, and political affiliations. In 1974, the city of Decatur and Adams County created an agreement that would allow the two departments to share equipment and staff.

In 1972, the joint department created the Superintendent and Secretary positions through a contract. Two additional positions, Director of Leisure Services and the Leisure Services Manager were added in 2009.

The Decatur-Adams County Parks and Recreation department hired a planning consultant to write a comprehensive five-year Master Park Plan in 2011 because up to that point the DACPR department was not operated under the guidance of a Master Plan.

1.5 Park and Recreation Department Staff

The DACPR Department currently has six full time employees including City Manager/Superintendent; Director of Leisure Services; Leisure Services Manager; Youth Sports Coordinator; Office Manager; Director of Maintenance. Additionally, the DACPR Department has 25 part-time and/or seasonal employees for summer grounds maintenance, lifeguards at the pool, and others.

1.6 Park Board Vision and mission Statement

1.6.1 Vision Statement

The Decatur and Adams County Park and Recreation Boards strive to provide beautiful, clean, and safe recreational spaces to enhance the quality of life and availability of assorted leisure activities for all citizens of Decatur and Adams County.

1.6.2 Mission Statement

The Decatur and Adams County Park and Recreation Boards strive to provide beautiful, clean, and safe recreational spaces and availability of assorted leisure activities to enhance the quality of life for all citizens of Decatur and Adams County.

1.7 Local Government Structure

The City of Decatur is governed by the City Council which is comprised of five members; four District members and one at-large member. The Decatur City Council develops City Ordinances, establishes and has authority over the City budget, public facilities and services, capital improvements, and the appointment of boards and commissions serving in the City's interest. The City Council works continuously to improve the quality of life and place in the City. The Council meets biweekly on the first and third Tuesday of each month.

Adams County is governed by a three member County Commission from three districts and a seven-member County Council comprised of representatives from four Districts and three at-large members. The County Council develops County ordinances, establishes and has authority over the County budget, public facilities and services, capital improvements and the appointment of boards and commissions serving in the interest of the County. The County Council meets the second Tuesday of each month at 8:30 am at the Adams County Service Complex.

The Park Boards for Decatur and Adams County each make decisions regarding upgrades, maintenance, and new amenities at the parks, as well as, help to set the Park Boards' budgets.

1.8 Park and Recreation Budget

The majority of the park budgets come from tax-based town appropriations. The budget has adequately met the needs of the park over the past; however, many parks and facilities are in need of upgrades, and additional park(s) or park services are desired within Decatur and Adams County to offer recreational opportunities to meet the needs of all who reside within the park's jurisdiction. Table 1 shows the Park and Recreation Budgets from 2016 through 2019.

2.0 Existing Conditions

2.1 Natural Features and Landscape

2.1.1 Geology

The landscape of northeastern Indiana is directly influenced by the last great glaciation which occurred over 14,000 years ago; the Wisconsinan glaciation. The glaciers filled and dammed rivers and flattened the rolling hills that were once present in northern Indiana. As the glaciers melted, they deposited rock, dirt, and sand that they picked up while traveling across the landscape. In the project area, scoured till-like sediments, locally capped by lacustrine silt and clay were left by the glaciers.

The bedrock in northern Indiana was deposited during the Devonian Period some 400 million years ago. The deposited rocks consist mostly of sedimentary rock. The predominant bedrock of the project area is primarily argillaceous dolomite, dolomite, and limestone. The last lobe of the Wisconsin glaciation, the Erie Lobe, left a sequence of deposits known as the Lagro Formation, which is responsible for the clayrich composition of the soils present within northern Indiana today. The surficial geology overlaying the bedrock in the project area consists of mostly silt, clay, loam or a combination of the different soil types.

The project area is located almost entirely within the Central Till Plain physiographic region and Bluffton Till Plain Sub-Region. The topography of the area is relatively homogenous. The average elevation is around 800 in the northern portion of the county and 840 in the southern portion of the county. There are some areas where the slope of the land may exceed 2% slightly, specifically near the St. Marys and Wabash Rivers, but overall the landscape of the project area is unremarkable.

2.1.2 Deciduous Forest

Adams County is located within the Eastern Temperate Forest ecological region and is dominated by Beech, Maple and Basswood trees. Adams County is a quarantine zone for the Emerald Ash Borer (EAB) as designated by the Indiana Department of Natural Resources (DNR) due to several sightings of the invasive insect that has infested many Ash trees located within residential areas, and even large forest stands. The IN DNR EAB locator map has several locations in Decatur and along the rivers marked as areas where the EAB has been identified. Due to the loss of Ash trees within Adams County, other tree plantings have occurred. However, expanding the tree planting program within Adams County through various grants and donations could help to improve the loss of tree cover due to the EAB.

2.1.4 Hydrography

Adams County is located within three 8-digit Hydrologic Unit Codes (HUCs) including the St. Marys River Watershed (04100004), which encompasses the majority of Adams County, the Auglaize River Watershed (04100007) in the northeastern tip of the county and both of which are part of the greater Western Lake Erie Basin. The southern portion of the county from the Ohio state line, through Berne to Vera Cruz is located in the Wabash River Watershed (05120101) and is part of the greater Mississippi River watershed which outlets into the Gulf of Mexico. There are two significant rivers that flow through the County which increases the ability for outdoor enthusiasts to view wildlife, birds, go fishing, or paddle the waterways.

There are 469 small ponds located within the political boundaries of Adams County though most are smaller than one acre (150 waterbodies are larger than 1 acre). Three Decatur Parks have large ponds including a 5-acre pond at Kekionga Park, a 5-acre pond at Bellmont Pond, and a 4.7-acre pond at the St.

Marys Nature Preserve in Decatur, both of which have fishing piers that are used regularly. Additionally, a 2.2-acre pond is located in Lynn Grove County Park.

With two large rivers and several streams and creeks located in Adams County there are several areas that are located within a 100 year flood hazard as identified by the Federal Emergency Management Agency (FEMA). These floodways are often ideal for open green space and passive recreation areas. The Adams County and Decatur Parks and Recreation have seven parks located within flood hazard areas. Most recently, the Decatur Parks and Recreation installed a Nature Preserve along the St. Marys River which floods each spring and is a great space to hold water so as to not cause flood damage to real property.

Two parks in particular were installed on land purchased through a FEMA grant. Modifications to traditional park design has been made at the St. Marys Nature Preserve including pervious parking, invasive plant clearing an installation of additional trees and water resistant vegetation. Kekionga Park is mostly green space with a small pavilion and play area. It also houses a large pond that can help with water retention when floodwaters rise. The other parks located in flood plains are located high on the banks and have not flooded in recent history.




Figure 2: Adams County Water Resources and Flood Hazards

Figure 2 on the next page shows the location of the water bodies and their flood hazards in Adams County.

2.1.2 Soils

Approximately 78% of the County is comprised of three major soil types including Pm - Pewamo silty clay with 0-2 percent slopes; BgmA - Blount silt loam which has 0 to 1 percent slopes; BgmB - Blount silt loam which is 2 to 4 percent slopes. These soils types are generally somewhat to very poorly drained. See Table 2 for a full description of these soils.

Of note is the soils listed above are classified by the Natural Resource Conservation Service as hydric based on them meeting one or more field indicators of hydric soils in the United States. These soil types may limit the use of some areas within parks and may indicate the historic presence of wetlands.

2.1.5 Wildlife, Birds, and Aquatic Life

The predominate wildlife present within Adams County are deer, raccoon, squirrels, opossum, and coyote. One may also observe the presence of fox and mink. Many birds of prey are found in the area as well including owls, hawks, and more recently bald eagles, especially along the Wabash River corridor where several nesting pairs have been found. With two large rivers running through Adams County fishing is a common hobby. There are several species of fish found in both the St. Marys and Wabash Rivers including some sport fish such as Walleye, Small and Largemouth Bass, Black and White Crappie, common carp, and spotted gar. There are several endangered species present in Adams County including mollusks, birds, reptiles and a mammal. Table 3 below shows which animals are listed on either the state or federal endangered species list.

2.1.6 Land Use




Figure 3: Land Use in Adams County

According to the 2011 National Land Cover Dataset (NLCD) Adams County is dominated by agriculture land, as is the surrounding area of Decatur as can be seen in Figure 3 below. Typical crops grown in the area are rotated between corn and soybeans and the fields drain via drainage tiles to open ditches and streams. Many farms are conventionally tilled which results in sediment loss from the fields, however more farmers are beginning to implement no or limited tillage practices which reduces farm field runoff. The majority of the land use within the town/city boundaries is classified as low intensity developed land with little developed land classified as high intensity. Most of the medium to high intensity developed

land is located within Decatur. The parks within Adams County are classified by the NLCD as developed open space.

2.2 Man-made, Historical, and Cultural Characteristics

Adams County was created by State statute in February 1835 and officially organized on March 1, 1836. The County seat was founded in 1836 when Samuel Rugg, and prominent business man who later became a state Senator, offered for the County seat to be situated on his land which consisted of four church lots, half an acre public square, 1 acre seminary, and two acres for a cemetery. Rugg also paid to locate the Commissioners to the new County seat and to furnish a house to hold official business. The County seat, Decatur, was likely named for Commodore Stephen Decatur, Jr. who was an American naval officer who served in the Barbary Wars and the War of 1812.

Many family and locally owned businesses are scattered throughout Adams County, and especially in downtown Decatur. The residents of Decatur take pride in their vibrant community and the City strives to provide a welcoming community for visitors and many amenities to ensure an exceptional quality of life for its residents. Decatur has a booming art focus with a community makers space, and the Decatur Sculpture Tour. There are also several festivals held in Decatur that celebrate the city and county's vibrant history including the Motorsports Festival, Germanfest, Dekegger Homebrew and BBQ Festival, Christmas Open House, the Callithumpian Festival, the Decatur Highland Games, Kekionga Festival (the latter two held in Riverside Park in Decatur), a weekly Farmer's Market, and summer concert series. Today, Adams County is home to a large Amish community who not only supplement the local economy but contribute greatly to the local culture with farming, hand-made crafts, and homemade foods.

2.2.1 Commercial and Industrial

Adams County has a booming industrial sector and a long list of businesses in the food processing industry including Red Gold Products, Bunge North America and three others. Table 4 lists the major industries located in Adams County. In addition to the larger industries, Adams County also is filled with small family owned restaurants, shops, farm stands, and more.

2.2.2 Transportation Links

Adams county is a prime location for businesses and individuals as it sits amongst four Indiana state roads, three U.S. Routes, and one railroad line. State roads include 101 which connects the county north to Angola; 124 which connects the county to Bluffton and I69 to the west and Lima, OH to the east; 218 which connects to I69 to the west and US Route 127 to the east; 116 which connects Jay County to the City to Geneva, Linn Grove, and Bluffton to the west. U.S. Routes in Adams County include 27 which connects to Fort Wayne to the north and Richmond to the south; 224 which connects to I69 and Huntington to the west and Van Wert, OH to the east and 33 which connects to 127 and St.

Marys, OH to the east. The rail line in Adams County is operated by RailAmerica and operates from Decatur to just southeast of Fort Wayne. The train's primary use is to haul goods from Central Soya located in northern Decatur.

In addition to motorized transportation the City of Decatur and South Adams Trails group have been working to increase its active transportation network. There are currently approximately 11.5 miles of multi-use trails in Adams County. This includes 7.61 miles managed by Decatur Parks and Recreation, approximately 1.75 miles managed by South Adams Trails and the remaining trails (2.14 miles) are owned by the IN DNR or privately owned.




Figure 4: NIRCC Bike and Ped Trail Plan for Decatur




Figure 5: NIRCC Bike and Ped Trail Plan for Adams County

The Bike and Pedestrian Trail Plan compiled by the Northeastern Indiana Regional Coordinating Council identifies a proposed 2 mile bicycle shoulder lane on Master Dr from N 2nd Street just east of US 27, south to 12th Street to Adams Street then south on 11th Street to Bollman Street which connects back to US 27. This shoulder lane will provide a safe pedestrian path from the north side of Decatur to the shopping plaza and Walmart on the south side of town. The Trail Plan also identifies four miles of planned trails within Adams County including trail connections in Decatur and the completion of the South Adams Trails trail connecting Geneva and Berne. Finally, the Trail Plan also identifies nearly 87 miles of proposed trails within the county. Figure 4 is a map depicting the trails and sidewalks (existing, planned and proposed) in Decatur, and Figure 5 is a map depicting the same for Adams County.

An extensive sidewalk inventory has not been mapped. Nearly all of Decatur's parks have a sidewalk that connects the park to residential areas. The smaller towns, including Monroe which is home to one County Park does not have sidewalks leading to the park. However, this is a small community and travel via street shoulder is relatively safe for park visitors. NIRCC has worked with Decatur to determine locations for sidewalks in the future. Figure 4 below shows the location of the planned and proposed sidewalk network in Decatur.

2.2.3 Historic Adams County

The Indiana State Historic Architectural and Archeological Research Database (SHAARD) shows greater than 500 historic sites and/or structures located within Adams County that are rated as "contributing" 151 historic sites and/or structures rated as "notable" and 64 that are rated as "Outstanding". Of these structures 11 are also listed on the National Register of Historic Places. Table 5 is a list of those national historic places.

2.2.4 Adams County Zoning




Figure 6: Adams County Zoning Map

The majority of Adams County is zoned for agriculture, however within the cities and towns there are areas specifically for commercial, industrial and residential uses. It should be noted the majority of the Town of Geneva is designated residential, but Decatur and Monroe have a mix of zoned areas. Figure 6 below is a zoning map for Adams County. It can be assumed that the area of Adams County not specifically identifies is zoned agriculture, with the exception of Berne, though the zoning information was not available for use in this Plan.

2.3 Social and Economic Factors

This Section will discuss the demographic and economic influences in Adams County and Decatur. All data described was taken from the 2010 Census unless otherwise stated.

2.3.1 Population




Figure 7: Change in Population

According to the U.S Census the population of Decatur and Adams County was 9,405 and 34,387, respectively, as of April, 2010. The population of Adams County has increased by 2.27% since the 2000 census, however the Decatur population has decreased by 1.35% since the 2000 census. The City of Decatur has recognized that its population is on the decline and is working hard to improve quality of life and place within the City to retain and attract new talent to the city. The city's efforts may be paying off as the 2019 population estimate (9,628) shows an increase of almost 2% from the 2010 census. Figure 7 shows graphically the population change between the past two US Censuses in Decatur and Adams County.

2.3.2 Age Distribution

The majority of people living within Decatur are age 18 to 65 years old (51.2%) which is close to the percentage of same aged people in Indiana as a whole (54.4%). However, while the majority of people in Adams County is between the ages of 18 and 65, the percentage is lower at 43.4%. The difference in age distribution between Decatur, Indiana, and Adams County is due to the large number of children in the County (40.7%) compared to the percent of children in Decatur (30.9%) and Indiana (29.5%). The high number of children in the County may be due to the large Amish population that resides in Adams County. Amish families often are larger than "English" families and according to AmishAmerica.com have an average of seven children per family. According to the Young Center at Elizabethtown College in Pennsylvania the Amish population doubles approximately every 20 years. For Indiana, the Amish population increased from 23,405 in 1992 to 54,825 in 2018. Since the County has a higher number of children it is important that the County park system offer recreational opportunities that appeal to the younger population such as play equipment, sports facilities, and open green spaces.




Figure 8: Median Age of Decatur, Adams County, and Indiana (2000 and 2010)

There is a slightly greater population of persons 65 or older living in Decatur than in Adams County or Indiana. This should be considered when Decatur Parks and Recreation are planning programs for Decatur residents to ensure that there are suitable activities for the aging population. Figure 8 below shows the percentage of age distribution in Decatur, Adams County, and Indiana according to 2010 US Census data.

2.3.3 Race

The City of Decatur and Adams County are less diverse than Indiana as a whole as 97.8% of the residents of Adams County identify as white alone according to the 2010 Census. Table 6 below shows the distribution of races in Decatur, Adams County and Indiana.

2.3.4 Disabilities




Figure 9: Percentage of Population Living with Disabilities

The estimated population living with disabilities of any kind below the age of 65 years old in Decatur is 2.1% greater than the estimate in Indiana and 3.9% greater than the estimate of those living with a

disability below the age of 65 in Adams County as a whole. There is a high margin of error in these estimates. However, due to the significant difference in estimates in Decatur as compared to Adams County and Indiana it is important that Decatur offer accessible play spaces for people of all abilities. Therefore, it can be assumed that the level of accessibility required for Decatur residents is extremely important and the Decatur and Adams County Parks and Recreation should strive to meet the requirements of the Americans with Disabilities Act and Architectural Barriers Act to the greatest extent possible. Figure 9 depicts the percentage of people living with a disability in Decatur, Adams County, and Indiana.

2.3.5 Socioeconomic Factors

Median household income in Decatur is lower than both Adams County and Indiana by approximately 14% and 20%, respectively. Additionally, the percentage of families living in poverty in Decatur is greater than those living in Adams County as a whole, and approximately 2% greater than Indiana. The higher poverty rate in Decatur may be due to the fact that estimates show fewer Decatur residents with a four-year degree (12.9%) than those in Adams County (15.5%) or Indiana (26.5%). Table 7 shows the income and poverty level and Table 8 shows the education level for residents of Decatur, Adams County, and Indiana.

2.3.6 Unemployment

According to IndianaStats 2019 data, the unemployment rate for Decatur's population 16 years of age and older is 3.9%, as compared to Adams County's unemployment rate of 2.7% and Indiana at 3.3%. The number of unemployed in Decatur and Adams County are within 0.6% of that of the state as a whole.

2.3.7 Occupations




Figure 10: Graphical Comparison of Occupation in Adams County

Due to the rural nature of Adams County the top industry is agriculture related. Farm proprietors employ nearly 15,000 individuals. Not taking agriculture into account the private sector employs over 17,000 individuals in Adams County with manufacturing (5,246) construction (2,329), healthcare (1,145) and retail (1,936) being the leading employers in Adams County. It should also be noted that the average drive time to work for Decatur and Adams County residents is approximately 20 minutes. This could lead one to believe that many people work outside of the City or County in larger, nearby communities such as Fort Wayne. Figure 10 shows the various occupations that Adams County residents have and Table 9 shows the mean drive time to work for residents of Decatur, Adams County, and Indiana.

2.3.8 Summary of Findings

Below is a summary of the findings related to the social and economic analysis that may influence park planning:

- The population of Decatur declined between the 2000 and 2010 Census but is rising according to estimates
- Adams County has a larger number of children likely a result of the large Amish community
- The median income is substantially lower in Decatur than in Adams County or Indiana
- The poverty level is 2% higher in Decatur than in Indiana
- The estimated percentage of individuals with disabilities is greater in Decatur than in Adams County or Indiana.
- The percentage of individuals with a bachelor's degree or higher in Decatur is lower than in Adams County or Indiana
- The majority of workers in Adams County work in agriculture, though manufacturing is also a large employer, as is healthcare, and retail.

3.0 Inventory

3.1 Parks Located within Adams County

There are several recreational opportunities available within Adams County. According to Indiana Maps data obtained from the IN DNR there are 51 different locations offering outdoor recreation including schools and churches, which are not always available to the public, and some private organizations that may require a fee. However, there are several recreation opportunities that are available to the public through other ownership including from the Indiana Department of Natural Resources, ACREs Land Trust, and the Decatur and Adams County Parks and Recreation.

To have an understanding of how the public uses the parks within Adams County, specifically those that are owned by DACPR, a public survey was made available between November 23 and December 31, 2020. The survey was advertised via the websites for the DACPR and City of Decatur and it was announced via a press release sent to two local newspapers the Decatur Daily Democrat and Berne Witness. The press release was also sent to the Adams County Economic Development Corporation, Decatur Chamber of Commerce, Geneva Town Hall, Monroe Town Hall and the Bellmont High School Radio 103.5. Paper surveys were available at the DACPR office in Decatur and they were available at two events involving the Amish Community in Adams County including a library and vaccination workshop. It should be noted that only one paper copy survey was completed and returned which was manually entered into the on-line survey by DACPR staff. There were 604 respondents to the survey and their responses are incorporated into the park inventory below where applicable and the full survey responses can be found in Appendix A.




Figure 11: Adams County Recreational Facilities – IndianaMap.org

The following sections will identify the public facilities and amenities located in Adams County. Each section will be divided into subsections according to park ownership. Figure 11 is a map showing the location of the 51 amenities identified in IndianaMap.org as provided by the Indiana Department of Natural Resources.

3.2 Decatur Parks and Recreation

The Decatur Parks and Recreation Board have jurisdiction over fourteen parks and the 10 mile trail system within Decatur's city limits. The DACPR recently acquired the playground at the NW school property in Decatur and they maintain the exterior amenities at the property. The DACPR also maintains the activities available in the Adams County Service Complex and maintains Founders Park (City of Decatur) and Bellmont Pond (North Adams Schools). The Park Planning Committee conducted an inventory of the parks. The results of the inventory are described below. Figure 12 below shows the location of the parks within Decatur that are managed by the Parks and Recreation Board.

3.2.1 American Legion Park

501 Winchester St. Decatur

American Legion Park, referred to by some as Cannon Park is 2.01 acres. Established in the 1920s with the help of the local American Legion, it was in need of updates and in 2012 a new ADA playground was added to the park. It also boasts a hard-surface sidewalk through the park and connects to the Rivergreenway Trail.

According to the Park Planning Committee, American Legion Park is used heavily and has an excellent ADA rating.

Responses from the public survey correspond with the **Planning** Committee's assessment that the park is used heavily as 56.4% of respondents marked American Legion Park as one of the most visited parks of those offered by the DACPR. Though, 1.5% of respondents mentioned that the park is need of upgrades and/or maintenance. As can be seen in the adjacent table, the Planning Committee

believes the park to be in excellent condition with the exception of the sand volleyball. It was noted by survey respondents that the sand at the volleyball court needs to be replaced with appropriate beach sand rather than the playground sand that is currently used. Finally, 31.47% of survey respondents noted they would like to see new amenities added to American Legion Park.

3.2.2 Bellmont Pond

Intersection of US 224 and N Piqua Rd

Bellmont Pond is located off US 224 on the east side of town nestled between Bellmont High School on Stadium Drive and N Piqua Rd. Bellmont Pond is on an 18 acre parcel of land with a .23 mile trail traveling through a wooded area and a five acre pond. The property is owned by North Adams Schools but maintained by the DACPR. Bellmont Pond is a passive park with no other amenities with the exception of the pond, wooded trail, and picnic table. The Park Planning Committee has identified that Bellmont Pond does not meet ADA requirements as it does not have a hard surface walking path or a parking area. Additionally, the Committee has identified usage of Bellmont Pond to be low and recognizes that it is not used as frequently as other parks.

The Committee's assessment is in line with that of survey respondents as only 11.45% of respondents indicated they frequent Bellmont Pond for their outdoor recreation. Two respondents answered that Bellmont Pond is in need of mainteance/updating. The public was asked which parks they would like to see new facilities and 13.46% indicated Bellmont Pond. It is not clear which amenities they would like to see at Bellmont Pond, however it could be trails (N=7), more fishing opportunities (N=6), mountain biking (N=4), more picnic areas or benches (N=4), or a place to accommodate gardens such as butterfly, flower, and prairie grasses since the park only accommodates passive recreation. Additionally, the public was asked if they would be interested in renting equipment such as paddle watercrafts and 380 respondents answered yes, with another 165 specifically writing in kayaks/canoes. Paddle sports could be utilized at the park on the five acre pond.

3.2.3 Eastbrook Park

409 Eastbrook Drive, Decatur

Eastbrook Park is a 4.6 acre neighborhood park located in Decatur. It is situated behind houses and not clearly visible from the street. The park is the traditional neighborhood park with play equipment swings, slides and the like.

The Park Planning Committee states the park is not used often and is not ADA compliant. As can be seen in the adjacent picture, the play equipment is not ADA, has a sand play surface and does not have a hard a solid surface leading to the equipment.

Eastbrook Park is one of the least visited parks according to the respondents of the public survey as only 1.35% or respondents indicated they frequent this park. One respondent noted that Eastbrook Park is in need of maintenance or updating and 14 respondents (2.9%) indicated they would like to see new facilities added to the park.

3.2.4 Founder's Park

172 N 2nd Street, Decatur

Founder's Park is what is referred to as a "pocket park" at just 0.14 acres. It is a small park in downtown Decatur at the corner of W Monroe St. and N 2nd St. across from City Hall. This park is owned by the City of Decatur but maintained by the DACPR. It includes seating, shade, and access to downtown amenities including the self-guided sculpture tour. It also connects to the Rivergreenway by way of sidewalks to the St. Marys Nature Preserve.

This park was not assessed by the Park Planning Committee as it is relatively new, in excellent condition, and ADA compliant. The



park was included in the public survey where respondents indicated the park is not visited frequently (6.57%). Founder's Park was not referred to in any other answers in the public survey.

3.2.5 Hanna Nuttman Park

Intersection of US 33 and N Washington Street, Decatur

Hanna Nuttman Park, established in 1932, is a 35.5 acre property that is heavily used. It is located on the northwest side of Decatur. Hanna Nuttman is Decatur's largest active park (St. Marys Nature Preserve being the largest passive park) and it is full of activities including ball diamonds used by youth and adult baseball and softball leagues, two play areas, a large green space, a large open air pavilion, many large mature trees, and two cabins which are owned maintained by the Boys Scouts and Girl Scouts.

The Park was in need of updates and be reconfigured to accommodate its heavy use. Additionally, the ball diamonds were no longer in safe working order, frequently flooded, and there were safety concerns at the park with the ball diamond layout and lack of parking availability. The development of the REV Sports Complex began in July, 2019 and is nearly complete. The redesigned Hanna Nuttman - REV Sports Complex consists of six ball diamonds, parking for 368 vehicles, two new restrooms and a concession building, fencing, and score boards. It is the desire of the DACPR to bring youth baseball back to Hanna Nuttman with this new state of the art facility.

The Park Planning Committee indicated Hanna Nuttman to be heavily used and ADA compliant with the new renovations. Responses in the public survey match that assessment as 46.8%

of respondents indicated they frequent Hanna Nuttman (second most visited park). However, it is possibly some of the public are not aware of the recent updates to the park as 10 respondents wrote in that Hanna Nuttman is in need of maintenance/updating. Other suggestions made for the park by survey respondents

include wind stopper around the pickleball courts and an amphitheater. It should be noted that while only two respondents specifically mentioned Hanna Nuttman Park in their responses, 40.58% of respondents believe that additional amenities should be added to the park.

3.2.6 Homestead Park

Homestead Drive, Decatur

Homestead Park, established in 1947, is a 15.9 acre neighborhood park located on the south side of town on Homestead Dr which is located across High St from Adams Memorial Hospital. The park has more amenities than the average neighborhood park as it has a baseball/softball field, basketball court, tennis court, benches, and swings and slides. Additionally, Homestead Park hosts youth soccer league and portable soccer goals are used in the park for this activity. The youth soccer league runs for eight weeks each fall.

Analysis by the Park Planning Committee indicates the park is heavily used but does not meet ADA requirements as the park has a gravel parking lot without designated handicap parking, or hard and solid surfaces leading to the park amenities. The public survey asked which parks the public frequents and responses indicate that Homestead Park is one of the most visited as 28.45% marked the Park as one they frequent (N = 169). Twenty-four respondents wrote in the

survey that Homestead Park was in need of maintenance and updating, which is also apparent from the Committee's analysis of the park. 26.29% survey respondents indicated they would like to see new facilities at Homestead Park.

3.2.7 Kekionga Park

101 Kekionga Park Rd, Decatur

Kekionga Park, established with a Land and Water Conservation Fund grant from the IN Department of Natural Resources in 1974, is a 31.1 acre park located in a floodplain east of Adams Memorial Hospital and adjacent to the St. Marys River. The park is located behind a neighborhood where, in recent years, homes have been purchased and demolished with FEMA funds which allows for expansion of the Park in the future. Kekionga Park has a pond with a boat launch which is often used for fishing and paddle sports. A DNR boat access site to the St. Marys River with hard surface parking is located in the park as well. Kekionga Park also has a covered pavilion available to rent, playground, basketball court, picnic tables, the county's only frisbee/disc golf course, baseball diamond, and green space. Additionally, Kekionga Park serves as a trailhead to the Rivergreenway trail system in Decatur.

The Park Planning Committee's analysis of the park identified that the park is used at a moderate level by the public and that it does not meet ADA requirements as it does not have a hard and solid surface to all amenities, has a soft playground base, and does not have a solid surface parking lot or designated handicap parking near DACPR owned amenities.

The public survey included a question about which parks are used frequently and the results of the survey indicate Kekionga Park is used at a moderate level as 25.25% of respondents indicated they frequent it. The public was asked which parks need maintenance or updating and 41 respondents wrote in Kekionga

Park indicating it is in certain need of attention. The public was aslo asked which parks need new facilities and 30.64% of respondents indicated that Kekionga Park needs new amenities.

3.2.8 North Ward Park

519 N 5th Street, Decatur

North Ward Park is located in central Decatur surrounded by residential homes and across 5th Street from Waterworks Park and the Decatur Public pool. The park is 0.6 acres and is located at 519 N 5th Street. North Ward Park has two full court basketball courts, a small skate park



including a small skate ramp on approximately 4,800 sq. ft. of hard surface and drinking fountain.

The analysis of North Ward Park by the Park Planning Committee identified that the park is used by the

public at a moderate level and has a poor ADA rating. There is not a designated parking area connected to the park amenities, no handicap parking, no hard and solid surface from the street parking to the

amenities or designated seating to view activities in the park.

Respondents to the public survey indicate that North Ward Park is the least frequented park as only 1% of respondents indicate they use the park. However, five respondents wrote in that North Ward Park is in need of maintenance and updating which indicates the park may be used more frequently than the 1% would suggest. Additionally, 2.69% of respondents (N=13) indicated that North Ward Park is in need of new amenities.

3.2.9 Northwest School Property

1109 Dayton Street, Decatur

The NW school property is located in Decatur and was recently given to the City of Decatur when it was no longer being used as a school. The City is working to identify potential uses for the building. The property is 7.28 acres and the exterior of the property includes a playground which was given to the Decatur Parks Department and was identified by the Park Planning Committee as needing updated. Other outdoor amenities

include the baseball diamond and four basketball hoops in the parking lot. The exterior of the property is

currently being maintained by the DACPR. The interior of the building has a large gymnasium that can be rented and is used for other activities including volleyball and basketball.

The Park Planning Committee's analysis of the property identified that it is not often used and does not meet ADA requirements as there is no seating to view baseball games, no benches or resting areas, and there is not a solid subsurface at the playground equipment.

The public survey results are in line with what was assessed by the Planning Committee as on 8.42% of respondents indicated they frequent the property and 14.91% of respondents answered they would like to see new amenities at the property.

3.2.10 Riverside Center Park

230 E Monroe Street, Decatur

Riverside Center Park is a 6.52 acre property behind Riverside Center adjacent to the St. Marys River. The park houses the DACPR administrative building, as well as a small gazebo, sand volleyball courts, benches or other seating, and several sculptures. Additionally, Riverside Park is a trail head for the Rivergreenway trail in Decatur, as a portion of the trail runs through the There has been discussion



within the City of Decatur and the DACPR about expanding development in the park which would include expanded trails and riverfront development. Additionally, river access for paddle sport rentals and access for individuals who own their one watercraft.

The Park Planning Committee's analysis if Riverside Park identified the park as used moderately and that it is not ADA compliant. However, there is a hard surface parking lot with designated handicap parking, a hard and solid surface from the parking lot

to the administration building, the gazebo and adjacent to the sand volleyball court. Therefore, the park itself is likely ADA compliant, but Riverside Center, the administration office may not be and will be discussed in Section 3.2.9.1.

According to survey results, Riverside Park is frequented by 7.58% of the respondents, and 13.5% of respondents (N=65) indicated they would like to see new facilities at Riverside Park.

3.2.10.1 Riverside Center

Riverside Center, erected in 1954, is located within Riverside Park at 231 E Monroe Street, Decatur. Riverside Center is home to the DACPR administrative offices, has rooms available for public or private meetings and events, and restrooms which are available to the public during office hours. The DACPR Board meetings are held in this space, as are other large local government led community events.

The Park Planning Committee's analysis of Riverside Center identified the Center is moderately used and does not meet all ADA



requirements. Specifically, the restrooms should be updated to meet current ADA standards.

3.2.11 South Ward Park

711 Winchester Street, Decatur

South Ward Park is a 0.74 acre park surrounded by residential homes. South Ward Park houses on ½ basketball court, play equipment including swings, a slide and merrygo-round.

The Park Planning Committee's analysis of the park identified that the park is not used often and it does not meet ADA requirements as there is not a parking lot with designated handicap parking, and compliant surface under the play equipment, or a hard a solid surface to the park's amenities.

The respondents of the public survey indicated that South Ward Park is one of the least used parks as only 1.85% of them responded that they frequent the park. Six respondents wrote in that South Ward Park is in need or maintenance and updating and 4.55% of respondents indicated they would like to see additional facilities at the park.

3.2.12 St. Marys Nature Preserve

Limberlost Trail, adjacent to St. Marys River, Decatur

The St. Marys Nature Preserve, established in 2017 with a Land and Fund grant Water Conservation awarded to the Decatur Park and Recreation Department, is a 47.49 acre passive park located on Limberlost Trail behind the shopping plaza on W Monroe Street and adjacent to the St. Marys River. The parking lot to the preserve is located within the Stratton Park neighborhood. The land was donated by the St. Mary of the Assumption Church in Decatur to be turned into a nature preserve and educational tool about the natural environment for residents in Decatur. The park includes a pervious parking lot located on property that was bought out with FEMA funds as it frequently floods. The parking lot includes bus parking as well as designated handicap parking. There is a .75 mile multi-use

hard surface trail through the preserve that connects to the Rivergreenway trail. There is a small pond on the property with a fishing pier which is also ADA compliant. There are several interpretive signs placed along the trail that describe the various ecosystems within the preserve.

The Park Planning Committee's assessment identified that the park is heavily used by the community and is ADA compliant.

The respondents of the public survey indicated that St. Marys Nature Preserve is moderately used as 19.02% of respondents (N=113) indicated they utilize the preserve and one respondent wrote in that the preserve is in need of maintenance. When asked if the public would like to see additional activities at the parks in the parks, five respondents indicated they would like more nature activities such as bird watching and nature tours, and three indicated they desire more places to accommodate pollinator and flower gardens and prairie grass plantings, all of which currently or can easily be added to the St. Marys Nature Preserve. This could be the intent of those respondents as 9.5% or respondents indicated they would like to see new facilities at the St. Marys Nature Preserve.

3.2.13 Stratton Park

401 Stratton Way, Decatur

Stratton Park is a 4.97 acre neighborhood park located within the Stratton Park neighborhood. Stratton Park has more amenities than is typical at a neighborhood park. The amenities include a baseball field, various play equipment, several picnic tables an open-air pavilion, green space, shade trees, and drinking fountain.

The Park Planning Committee's assessment identified that Stratton Park is not a highly used park and it does not meet ADA requirements. The parking lot is not a hard and solid surface and does not have designated handicap parking, there is not a hard and solid surface to the park's amenities, and the play ground does not have a stable surface.

The respondents of the public survey indicated the park is not used often but more so than nine other DACPR parks as 7% of respondents responded they utilize the park. Twenty-one respondents wrote in the public survey that Stratton Park needs maintenance and updating. When asked which park is in need of new facilities, 10.56% of the respondents (N=51) indicated they would like new facilities in Stratton Park.

3.2.14 Waterworks Park

602 N 5th Street, Decatur

Waterworks Park was the very first park established in Decatur in 1895. It is a 3.79 acres park located across from North Ward Park surrounded by residential homes. Waterworks Park is home to the Decatur pool which includes two lap lanes, a diving board, two slides, a water bucket dump, baby pool, and concessions. The pool was poured in 1920 with the help of the Decatur Rotary Club. The park also hosts playground equipment, picnic tables, and bike racks. The DACPR offers many programs already, and the public was asked which programs they participate in. 63.24% of the answered respondents they participate in swim lessons, and 30.66% answered they participate in aquatic exercise classes. classes and lessons take place at the Waterworks Pool, however, it should be noted that the DACPR has a partnership with Bellmont High School to utilize their pool for these activities during the cold weather season.

The Park Planning Committee's assessment of Waterworks Park identified that the park is moderately used, though more frequently in the summer as the pool opens, and that it does not fully meet the

requirements of the ADA. There is a solid surface parking lot with designated handicap parking, a compliant ramp to enter the pool house, and sidewalks leading from the parking lot to the pool house and the pool entrance. However, there is not a hard a solid surface to all amenities within the park and they playground does not have an ADA compliant surface.

The respondents of the public survey are in line with the assessment of the Planning Committee as 5.89% of the respondents (N = 35) indicated they frequent Waterworks Park. Nineteen respondents wrote in that Waterworks Park/Pool are in need of maintenance and updating. The public was asked if they would

like to see additional amenities added to the parks and 24 respondents answered they would like more swimming opportunities, indoor pool, upgraded pool or heated pool. An additional four respondents answered they would like to see a water park and six answered they would like a splash pad added to the parks. It has been discussed within the DACPR to add additional water features to the park which may include a Splash Pad. The respondents may have intended these additional amenities to be added to Waterworks Park as 14.91% respondents (N = 72) indicated they would like new facilities to be added to Waterworks Park. Finally, three respondents left comments regarding leaving the pool open later, and

another respondent suggested pool rentals.

3.2.15 Worthman Field

1216 Adams Street, Decatur

Worthman Field is a 4 acre park located at the corner or US 27 and Adams in Decatur. The park was donated to the DACPR from the schools and it includes a baseball diamond with a set of bleachers for each team, dugouts, batting cage, soccer field, ¼ mile gravel running track, play equipment, an open air pavilion with restrooms and picnic tables, and a large parking area.

The Park Planning Committee's assessment of the park identified that the park is heavily used by the public and does not meet ADA requirements as the paths to the bleachers, the playground subsurface and track are all gravel. The parking lot is a hard surface though it does not have designated handicap parking.

Respondents to the survey indicated that Worthman Field is one of Decatur's well visited parks by the public as 17.68% answered this is a park they frequent. Eleven respondents wrote in that they believe Worthman Field is in need of maintenance and updating. One respondent suggested that better

parking is needed at Worthman Field, Picture acquired from Adams County website: www.co.adams.in.us especially during the busy soccer season but when asked where new facilities should be installed 13.66% of respondents answered Worthman Field was in need of new facilities.

3.2.16 Adams County Service Complex

313 W Jefferson St, Decatur

The Adams County Service Complex, also referred to as the Annex, is located at 313 W Jefferson St. in Decatur on three parcels of land totaling 1.2 acres. It is owned by Adams County Commissioners and houses the county administrative offices. This former school was turned over to the county in 1995 as a community asset. The DACPR operates the community amenities inside as well as hosts many community programs there. Amenities at the Annex include an open gym for basketball, however the gym can be rented for other activities for a small fee. Other amenities include a rock climbing wall, fitness center with six treadmills, four elliptical machines, one recumbent bike, one upright bike and a weight room, and a pickleball court which is free and available at certain times during the week. Two leagues are run out of the Annex including the women's volleyball league and men's winter basketball league.

The Park Planning Committee analyzed the Annex and identified that it is a real asset to the community and is heavily used. However, they gave it an ADA

rating of poor to fair. There are two entrances to the building that meet ADA requirements, however the interior of the building will need some updating to meet all ADA requirements.


The Annex was not included in the public survey specifically, however one respondent wrote in that they visit the Annex frequently and two respondents wrote in that the Annex is in need of maintenance and updating. Nine respondents wrote in that they would like to see indoor basketball courts, exercise equipment, sports complex, and practice facilities. It is possible these respondents are not aware of the amenities available at the Annex. The public was asked which programs they participate in the most and many of the top answers were activities/programs offered at the Annex including fitness center (43.55%), gymnastics (43.03%), and rock climbing (21.95%). The public was given the opportunity to suggest other activities not currently offered by the DACPR and many responses are of activities that could be added to the Annex in the future, or are activities the public is not aware are currently offered at the Annex including large indoor space with playground, dog park, gymnastics or exercise space (N=4), exercise classes including yoga, thai chi, pilates, and Zumba (N=7), and various dancing lessons or events (N=2).

3.2.17 Decatur Trail System

The DACPR manages the trail system within Decatur. There are currently 7.61 miles of trails in Decatur. The River Greenway which runs adjacent to the St. Marys River is 2.01 miles long and there are 1.85 miles of trail that occupy old rail beds. The IN DNR has approached Decatur about taking additional rail bed within the city limits. This property will be donated to Decatur from the state if Decatur decides to move forward with the acquisition. There is an additional 1 mile of trail planned in Decatur and another 50 miles of proposed trails within the city.

There are trails that connect American Legion Park, Kekionga

Park, St. Marys Nature Preserve and Riverside Park. Other parks are connected to the trail system via sidewalks including Hanna Nuttman and Founders Parks.

The public survey requested respondents to mark their top three priorities for adding amenities to the parks and 52.27% of respondents indicated that additional trails was a priority. The survey did not have specific questions about the trail system, however, several people made trail specific comments including safety of the trails (N = 1), fix cracks and broken areas of river greenway (N=1), fix wooden bridge on trail (N = 1), stop flooding at trails (N = 1), new trailhead near wood/iron bridge (N = 1), add mile markers on the trails (N = 1) add more trails (N = 7), add a trail connecting to Allen County (N = 1) (this is one of the proposed trails in Adams County).

3.3 Adams County Parks

Adams County Parks and Recreation Board has five parks under its jurisdiction. The Park Planning Committee conducted an inventory of the parks and their analysis of each park is described below. It should be noted that 74.12% of the survey respondents answered that they live in Decatur, so the answers regarding frequency of use and others from the survey may not accurately reflect the use or needs of the parks in the greater Adams County area. Figure 13 shows the location of the parks that are the responsibility of the Adams County Parks and Recreation Board.

3.3.1 Fields Memorial Park

978 Rainbow Road, Geneva

Fields Memorial Park is an approximately one acre plot of land. It is a passive park and home to the South Adams Trail group's first trailhead. The trailhead has hard surface parking for eight vehicles including two handicap spaces, a bike rack, four benches, and a restroom building with two drinking fountains. There is approximately one mile of trail from this spot, but the South Adams Trails group intends to continue the multi-use trail to connect Geneva and Berne. Fields Memorial also connects to Limberlost Park via a multiuse trail (0.75 mile).

The Park Planning Committee believes this location is getting more use the more residents become aware of the trail and believe it will be used extremely often as the trail construction continues. The Park Planning Committee rated Fields Memorial Park as having an excellent ADA rating. To meet all requirements wheelchair resting pads adjacent to benches need to be added.

Respondents to the survey indicated that Field Memorial is not currently used often as only 3.03% of respondents indicated they frequent the park and only 2.9% answered they would like to see new facilities added to the park. However, this may be misleading because it is possible that individuals utilizing the trail head may not realize it is located within Fields Memorial Park. When asked if there are additional activities, they would like the DACPR to offer two people wrote in a walking club and this park would be an ideal meet up location.

3.3.2 Limberlost Park

9486 CR 950 S, Geneva

Limberlost Park is a passive park adjacent to the Wabash River. It is approximately 64 acres in size and contains green space and a wooded riparian area. The Adams County Park Board has discussed improving the area with native prairie plantings. Limberlost Park is home to the historic Ceylon Covered Bridge built in 1860. The park has an open-air pavilion two picnic tables and one bench. The



park does not currently meet ADA requirements as it has a gravel parking lot and no designated handicap parking.

Respondents to the survey indicated that Limberlost Park is not used often as only 3.37% of respondents indicated they frequent the park and only 4.97% answered they would like to see new facilities added to the park. However, as indicated above, only 25% of the survey respondents live outside of Decatur, therefore the majority of survey respondents most likely were thinking of parks located within their

city specifically. Several respondents noted they would like to see more nature related activities and additional butterfly and flower gardens and prairie grass plantings and Limberlost Park would be an ideal location for these additional DACPR amenities.

3.3.3 Linn Grove Park

6998 S 500 W, Berne

Linn Grove Park is another passive park offered by the Adams County Parks. The park is 13.6 acres and includes many large shade trees and open green space. It also has an open-air pavilion, two picnic tables, and two ponds that are frequently used for fishing. The park does not currently meet ADA requirements as it has a gravel parking lot, with no handicap parking, does not have a hard and solid surface to park amenities, nor does it have accessible fishing locations on either of the ponds.

Respondents to the survey indicated that Linn Grove Park is not frequented as only

2% of respondents indicated they frequent the park and 1.45% of respondents answered they would like to see amenities added at Linn Grove Park. However, two respondents wrote in that Linn Grove is in need of maintenance indicating that the public does have concern for the parks availability in the community. Linn Grove Park would be another ideal location for additional natural activities and gardens. When the public was asked if there are activities not currently offered by the DACPR they would like see added six respondents wrote in fishing facilities/tournaments. Linn Grove Park would be an ideal location for these types of activities. One respondent also emphasized the need to maintain the ponds due to a large fishing community in Adams County.

3.3.4 Monmouth School Ball Diamonds

CR W 850 N east of N Piqua Rd, Decatur

Adams County Parks and Recreation acquired the Monmouth baseball diamonds from the local church when they closed the Monmouth School. The building is being leased to various

organizations. The property managed by the DACPR is 14.62 acres and includes three youth baseball fields, one t-ball field, bleachers, dugouts, announcer stand, batting cage, and picnic tables. The park is used seasonally for youth baseball.

The Park Planning Committee assessment of the park indicated that it does not meet ADA requirements. It has a hard surface parking lot but the path leading to the baseball facilities from the parking lot is gravel and not stable.

Respondents to the survey indicated that Monmouth Ball Diamonds are frequented at a moderate level as 9.6% of the respondents stated they frequent it and four respondents wrote in that the ball diamonds are in need of maintenance and updating. The public was asked if there are other activities not currently offered by DACPR they would be interested in and three respondents wrote in an adult baseball/softball league. With the new ball fields at Hanna Nuttman Park, Monmouth Ball Diamonds could be an ideal location for such as league.

3.3.5 Lions Park

380 Park Street, Monroe

The Monroe Lions Park, partially funded with a Land and Water Conservation Fund grant through the IN DNR, is a 6.16-acre park located in Monroe. It is the only park available within Monroe's boundaries and is in walking distance to many residential homes. The park houses swings, a slide for younger children, merry-go-round, teeter totter, climbing equipment, bench swings, horseshoe pits, hitching post, an open-air pavilion with picnic tables and a pond used for fishing.



The Park Planning Committees analysis of the part identified that it is used at a moderate level but does not meet ADA requirements. The parking lot is gravel as is the path to the pavilion. There is not a hard and stable surface to any of the amenities available at the park and the playground does not have a stable subsurface.

The public was asked how often they frequent DACPR parks and 3.87% of respondents indicated they frequent Monroe Lions Park, and six respondents wrote in that the park was in need of maintenance and updating and one respondent mentioned the Monroe park does not meet the needs of older children.

3.4 Other Recreational Facilities

There are several other outdoor recreation opportunities in Adams County offered by other organizations including the IN DNR, ACRES Land Trust, and private entities. Table 10 below outlines the other available outdoor recreational facilities in Adams County. However, there are three golf courses and other private/for-profit businesses that offer outdoor recreation that are not listed. There are also 15 schools located in Adams County, most of which leave their outdoor amenities available to the public when school is not in session. These amenities include outdoor tracks, basketball and tennis courts, baseball fields, and play equipment. It should also be noted that the DACPR has a partnership with Bellmont High School to offer indoor swimming opportunities at specific times.

3.4.1 Adams County Trails

While Decatur has been working to increase their local trails, the South Adams Trail group has been working to increase connectivity between southern Adams County's towns and cities and the Adams County Parks in the southern portion of the County. There are currently XXX miles of trails in the County, not including the 7.6 miles of trail in Decatur. Figure

3.5 Park Programming

The DACPR offers many programs to the public as part of their service to the community to enhance leisure activities. These programs are well attended by residents of Adams County. Youth activities offered include swim lessons, gymnastics, fall soccer, a summer day camp, daddy daughter and mother son dances, basketball, indoor rock climbing, girl's softball, football, and baseball. Adult programs include pool aquatics, the fitness center, women's indoor volleyball, men's basketball, aerobics classes, men's softball, and co-ed softball. Senior activities include aquatics, senior weights, senior luncheon, bingo, paint club, and euchre club, The public survey asked which programs people attend and respondents indicated they participate in swim lessons, youth soccer, the fitness center at the Adams County Service Complex, and gymnastics the most. Table 11 below shows how respondents answered this question.

The public was given an opportunity to write in other programs they would like the DACPR to offer. The most requested programs include paddle sports (N=7), youth/flag football (N=6)(youth football is currently offered to fourth through 6th graders by an outside organization), racquetball (N=6), and tennis lessons (N=5) (tennis is offered through high school tennis camps in the summer), more soccer including kids and adults (N=5) and sand and youth volleyball (N=5). The full list of suggested programs can be found in the public survey results in Appendix A.

3.6 Access to Exercise and Outdoor Recreational Opportunities

According to *County Health Rankings and Roadmaps* (www.countyhealthrankings.org) Adams County ranks 40th out of 92 in the state for overall health outcomes. The state of Indiana ranks at 75% as a whole for its population having reasonable access to exercise opportunities. However, larger municipalities, the major population centers have greater access due to them having private gyms, YMCAs and more parks in general than Adams County. Indiana top performers range in the 91% for access to exercise. *Note: Individuals are considered to have access to exercise opportunities if they* 1)

reside in a census block that is within a half mile of a park; 2) reside in an urban census block that is within one mile of a recreational facility; or 3) reside in a rural census block that is within three miles of a recreational facility.

Local, state and national parks, and facilities including gyms, community centers, YMCAs, dance studios and pools are included in the "Access to Exercise Opportunities" measure. It should be noted that not all these types of facilities are available in Adams County.

Indiana recently compiled its Statewide Comprehensive Outdoor Recreation Plan (SCORP) which is a "resource that quantifies and analyzes the state's outdoor recreation resources for social, environmental, health and economic benefit of citizens statewide". The SCORP is for years 2021 – 2026 and is intended to support local, regional, and state-level recreation decision making, as well as foster research, partnerships and cooperation among users, planners, government officials, nonprofits, and the private sector. It describes how Indiana has set a LOS of 0.02 acres of outdoor recreational space including parks, recreation, and open space available per person.

According to the SCORP, Adams County is short of recreational space available per person by nearly 50%, or 355.75 acres.

3.7 Accessibility and Universal Design

The City of Decatur and Adams County are responsible to ensure that all activities and facilities offered by the Decatur and Adams County Parks and Recreation Departments are accessible to residents and visitors of all abilities. The Park Board is committed to ensure that all new facilities and renovations are constructed to be compliant with the Americans with Disabilities Act (ADA).

3.7.1 ADA Self Evaluation and Transition Plans

The City of Decatur completed their ADA Transition Plan in December, 2011 and released a revised version in January, 2016. City staff performed the visual inspections of municipal buildings, sidewalks, and curb ramps. The inspection did not include park amenities. Due to the age of most of Decatur's parks, most amenities and facilities are not compliant with ADA requirements. An evaluation of the parks by NIRCC staff indicated that the parks are not in compliance with ADA regulations and as improvements are made, they will need to meet Consumer Product Safety Commission (CPSC) and ADA requirements. Additionally, all sidewalks must meet ASTM 1951-99 requirements and all park amenities must meet ASTM 1951-99 and ASTM 1242-99 requirements. The St. Marys Nature Preserve and the newly renovated Hanna Nuttman Park do meet these requirements. The Decatur ADA Transition Plan identified 69 sidewalk curbs that are in need of repair or modification and 180 which are in need of reconstructions. The City has prioritized these repairs and reconstructions based on their location along major thoroughfares and to those locations which provide access to public or government services.

Adams county completed their ADA Transition Plan and 2013 and adopted their revised Plan on January 26, 2021. County staff performed a visual inspection of the County's curb ramps and have determined they are all in compliance. There has not been a thorough inspection of the County owned buildings or parks. Though, as noted in the above park inventory, the County parks and the Service Complex do not currently meet ADA requirements and as renovations are made to the facilities they will need to be brought up to date to meet Consumer Product Safety Commission (CPSC) and ADA requirements.

Both Decatur and Adams County promote the ADA transition plans and encourage public participation. The Plans are available at local government buildings, Work Force One, libraries, Post Office, Chambers of Commerce, Decatur Housing Authority, financial institutions, realtors, churches and schools.

3.8 Summary of Findings

Below is the summary of the findings related to the park inventories and public survey conducted as part of the park planning process:

- American Legion Park, Hanna Nuttman Park and Waterworks Park and Decatur Pool are the most used parks in Adams County.
- The least used parks are North Ward, Eastbrook, South Ward, Linn Grove Park, Fields Memorial, Limberlost and Monroe Lions Park. Most of these parks are located in the county and survey responses may not accurately reflect their actual use (with the exception of North Ward, Eastbrook and South Ward Parks).
- Improving the pool and adding a splash pad are desires of the public.
- The top additional amenities desired by the public are a splash pad, additional trails, and a dog park.
- There is additional space to expand the Decatur Park system at Kekionga Park and increase access to natural features at the County Parks.
- There is opportunity to expand Decatur's trails through an old rail line offered by the IN DNR.
- The most popular park programs include swim lessons, youth soccer, fitness center and gymnastics.
- Survey respondents indicated they would like additional programs that are already offered indicating a possible need for an examination of information dissemination.
- Most of the parks do not meet ADA requirements, however newer parks and new facilities do
 meet ADA requirements. Additionally, with a higher percentage of disabled individuals in
 Decatur than in Adams County or Indiana, it is important to ensure ADA compliance at parks in
 Decatur specifically.
- Several parks need maintenance or updating of the facilities and amenities which may warrant a new method of overseeing the maintenance and updating of all the parks.

4.0 Public Participation

To ensure that a park plan meets the needs of the community it is important to provide ample opportunity for the public to provide their input into the park system and what their recreational needs and desires are. The Decatur and Adams County Parks and Recreation boards have worked to provide the community with as many opportunities to provide input as they can including a public input survey. However, due to the Covid-19 public health emergency, it was decided that a public meeting was not reasonable during the winter months of writing the Plan. However, an on-line Zoom public meeting, an in-person meeting with limited capacity, and the Park Plan final draft being placed at several locations throughout Adams County to allow the public the opportunity to review it and leave comments if desired were conducted after the final draft was completed. This will be discussed in detail in Section 6.

4.1 Park Board Meetings

The Decatur Parks and Recreation Board and Adams County Parks and Recreation Board hold their meetings on the second Monday of each month; Adams County at 6:00pm and Decatur at 7:00pm in Riverside Center. Progress on the 5-Year Master Park Plan was presented at each meeting and questions addressed. The meeting minutes from all Park Board meetings since September 2020 when the planning process began are in Appendix D.

4.2 Public Input Survey

A survey was constructed to gather public input on the current parks and amenities and gauge interest in additional amenities, as well as understand who uses the parks in Decatur and Adams County. It was available by hard copy at the DACPR office located in Riverside Center in Decatur and online via a Survey Monkey survey. It was advertised via a press release (Appendix B) sent to the Decatur Daily Democrat and the Berne Witness newspapers. The press release was also sent to Geneva Town Hall, Monroe Town Hall, and the Belmont High School Radio 103.5. Additionally, the survey was advertised through the websites and social media for the Adams County Economic Development Corporation, Decatur Chamber of Commerce, the DACPR social media page, and the City of Decatur government website. Finally, to reach the Amish community within Adams County, paper copies of the survey were brought to a library program and a vaccination workshop for the Amish.

There was a great response to the survey as 604 individuals participated. However, there were no paper copies of the survey received indicating that the Amish community did not supply input toward the Park Plan through the survey. Survey results were incorporated into the park inventory above and a copy of the survey and the results are in Appendix A. Below are key points from the survey results.

- 74% of the respondents live in Decatur, and 17.9 live in the rural area of Adams County
- 50% of respondents were between the age of 25 and 44 years old and 26% was over the age of 55 years old
- 70% of respondents have children under the age of 18 living with them
- 81.7% of respondents view outdoor recreation as extremely or very important and only 2.5% view outdoor recreation as not important
- 45.14% of respondents visit the parks at least once a week; 31.21% visit the parks once a month; 4.2% visit once a year; and 17.28% visit the parks seasonally for sports activities

- When asked which five activities are most important in the community the top answers included walk/run/jog (indicating the importance of trails or running paths); playgrounds; the multi-use trail system; swimming; and field sports with court sports coming in just 9% lower
- 54.32% of respondents live within the area the above-mentioned activities are offered; 34.88% have to travel some to reach the activities
- When asked which parks are most often used the top five answers were American Legion Park (56.4%); Hanna Nuttman Park (46.8%); Decatur Pool at Waterworks Park (33.84%); Homestead Park (28.45%); Kekionga Park (25.25%); and Riverside Center (22.39%). The least visited parks were North Ward Park (1.01%); Eastbrook Park (1.35%); South Ward Park (1.85%); Linn Grove Park (2.02%).
- 63.29% of respondents view the general condition of the parks and their facilities as good or high quality; 34.88% believe the quality varies from park to park
- When asked which park is in need of maintenance the top five written answers were Kekionga Park (N=41); Waterworks Park/Pool (N=34); Stratton Park (N=24); All/Most parks (N=16)
- 67.94% of respondents travel less than 10 miles to participate in most recreational activities; 21.10% travel 10 20 miles
- 78.96% of respondents visit the parks with family and 11.19% visit with friends
- When asked which three amenities respondents would like added to the parks the top answers included splash pad (70.76%); additional trails (52.27%); dog park (42.18%); grills and picnic areas (22.86%); and more passive recreation (20.67%)
- Respondents were given the opportunity to write in activities they would like to participate in
 that are not currently offered. The top answers included more swimming opportunities (N=24);
 pickleball (N=21); indoor basketball/exercise equipment/sports complex/practice facility (N=9);
 expanded greenway and trails (N=7); fishing facilities (N=6); tennis courts (N=6); and splash pad
 (N=6)
- When asked which park they would like to see new amenities the top answers included Hanna Nuttman (40.58%; American Legion Park (31.47%); Kekionga Park (30.64%); Homestead Park (26.29%); and waterworks park and the Northwest School Property (14.91% each)
- 90.27% of respondents would like to see more trails connecting the communities in Adams
 County
- 73.3% of respondents believe it to be extremely or very important for the parks department to offer programs to the community which only 3.7% believe it to not be important
- Respondents were asked which park programs are most important to them; the top answers include swim lessons (63.24%); youth soccer (57.84%); fitness center (43.55%); gymnastics (43.03%); youth basketball 32.06%); and aquatic exercise classes (30.66%)
- Respondents were given the opportunity to suggest other programs not currently offered. The
 top answers included paddle sports (N=7); youth football/flag football (N=6) (it should be noted
 this is offered by an outside organization in the area); racquetball (N=6); tennis (N=5) (it should
 be noted the high school offers tennis camps and instructions); soccer for adults and children
 (N=5); sand volleyball and youth volleyball (N=5) (there is currently only a women's volleyball
 league
- Respondents were asked of their interest in the parks department offering rentals for things such as paddle sports and bean bag toss. Top answers included kayaks and canoes (N=159); yes to all suggested rentals (N=69); bean bag toss (board and bags) (N=13); and frisbee golf (N=4)

• Respondents were asked to provide any additional comments. Top comments included "great job", "Thank you", "love the parks" (N=77), and "add a splash pad" (N=5)

4.3 Analysis

After examining the results of the public meetings and survey, the DACPR gleaned information vital to improving the Parks and Recreation system within Decatur and Adams County to benefit and meet the needs and desires of the residents of Adams County. The following subsections will outline the main points gathered from the public and the priorities as measured by the DACPR Planning Committee.

4.3.1 Public Perception, Needs, and Wants

The below key points regarding the Decatur and Adams County Parks and Recreation system were identified through the public surveys and park inventories.

- The parks in general are used frequently and valued by the community.
- There is a great desire to install a splash pad, upgrade the public pool, install a dog park, and expand the trail system.
- The majority of the parks do not meet ADA requirements and work should begin to ensure they do meet the needs of all area residents.
- Only one park, Monroe Lions Park, has a hitching post to accommodate the large Amish community in Adams County. More parks are in need of hitching posts.
- Water activities are of interest to the public as there are several small lakes, and two rivers (Wabash and St. Marys) that pass through the County.
- Many are interested in renting equipment for outdoor recreation. Kayaks and canoes were of most interest, and bean bag toss and disc golf to a lesser extent.
- The public survey revealed that the public is interested in participating in several activities including football, tennis and would like the Parks Department to offer these programs. These programs are offered by other organizations in the area indicating the need for stronger communication between the DACPR and other organizations that offer community wide recreation opportunities.
- Several parks are aging and in need of repairs or updates
- Only the playground at Hanna Nuttman Park is ADA compliant with a soft solid surface under it.

4.3.2 Priorities

The DACPR Planning Committee examined the results of the public input they received through the surveys to prioritize Park improvements based on the desire of the public. The survey results were discussed in depth at a meeting held on January 6, 2021. It was decided at that meeting that the top priorities as determined by the public would be compiled into a weighted survey to be taken by the Planning Committee members, while also taking into consideration feasibility of the improvements and additional amenities and available funding.

The prioritization survey included the top 14 amenities suggested by the public, eight activities/programs suggested by the public, and a list of all the parks to prioritize maintenance. All of these question's answers were weighted to provide a clear prioritization. The survey also included six equipment rental opportunities suggested by the public and the Planning Committee was asked to mark those they would like the DACPR to offer. Table 12 - 15, below show the results of the prioritization survey completed by the Planning Committee.

Any amenity scoring higher than 8pts was considered a priority to be completed within the next five years. These included increasing the length of the multi-use trails in Adams County, installing a dog park and splash pad, add more grills and picnic areas, install additional boat access sites to the rivers, and increase the availability of passive recreation.

Many of the above-mentioned programs are already offered by the DACPR such as volleyball, or they are offered by other organizations in Adams County including yoga/Pilates offered by the library and tennis offered by the local high school. The DACPR Planning Committee determined that they should work with these other organizations to help promote the recreation and team activities being offered by other organizations in the area.

During the discussion of survey results it was suggested that the DACPR determine a rotating schedule to assess the parks and make necessary improvements or upgrades following that rotating schedule. The results of the above prioritization will be used to determine what parks will be included in the rotation, starting with those that are in need of the urgent repair and maintenance (Kekionga Park, Waterworks Park, Stratton Park, Worthman Field, and Homestead Park being within the first year's rotation).

Based on the public survey and prioritization results, below is a list of the Priority 1 and Priority 2 upgrades, programs, and maintenance requirements.

- Priority 1 (0 5 years)
 - Determine maintenance schedule
 - Update bathrooms at Riverside Center to meet ADA requirements
 - Update 10% of Decatur's playgrounds to meet NPSI and ADA requirements
 - o Update Monroe Lions Park to meet NPSI and ADA requirements
 - Install additional grills and picnic areas
 - o Repair and upgrade Decatur Public Pool
 - o Ensure the Adams County Service Complex meets ADA requirements
 - o Increase marketing on available park and partner amenities and programs
 - o Install hitching posts at parks to allow ease of access for Amish Community
 - o Acquire available land for additional trails and support area trails groups
 - o Partner with other organizations to offer additional park programming
 - o Implement equipment rental program for Paddlesports, bean bag toss, and frisbee golf
 - Install dog park
 - Create more passive recreation opportunities
- Priority 2 (5 10 years)
 - Update all play structures to meet Consumer Product Safety guidelines
 - o Ensure all parks have a hard and solid surface to park amenities
 - o Install heat unit in pool to extend swimming season
 - Have additional multi-use trails installed
 - Install additional pickleball courts
 - Design a permanent sports complex
 - Install frisbee golf course

5.0 Final Public Comment Period of 5-Year Master Park Plan

In a joint meeting with Decatur and Adams County Parks and Recreation Boards on March 8, 2021 the Park Plan was discussed, the priorities list and proposed Action Register read out loud and discussed in detail and the draft plan was approved by both Park Boards. To ensure that the public has as many opportunities to review the draft plan before final approval by the IN Department of Natural Resources and officially adopted by the Park Boards, two public meetings (on-line and in-person) were held, and the draft plan was available at several public spaces to be read and reviewed with the opportunity to leave comments. The following sections discuss the review process and any comments that were made.

5.1 Public Review Methods

The final draft Decatur and Adams County 5-Year Master Park Plan was available to the public to read through and leave comments beginning April 6, 2021 through April 30, 2021 at the following locations: Adams County Public Library branches in Decatur, and Berne, the Geneva Public Library, Riverside Center, the Service Complex, and at two stores frequented by the Amish Community including one in Berne and another in Geneva. Additionally, the draft plan was available for review on the Decatur-Adams County Parks and Recreation website (www.daparks.com).

Park Plan reviewers were asked to complete a comment card and place it in the back of the Plan binder or send comments or questions to Kyle Quandt at kyle.quandt@co.allen.in.us. The comments received from anyone who read the draft Park Plan were forwarded to the Planning Committee and addressed as necessary.

In addition to hard copies of the draft Plan being available for review, the Planning Committee hosted two public meetings. An online Zoom meeting was held on April 14 at 5pm and an in-person meeting was held at Riverside Center in Decatur on April 15 at 6pm.

5.2 Public Comments and How they were Addressed

It was reported that over a dozen people from the Amish community reviewed the Park Plans, but only three comments were left. Comments included two regarding the need for restrooms at County owned parks and two regarding the need for hitching posts. Ten additional comments were made after the community reviewed Plans available in other locations. All ten comments referred to the need for additional pickleball courts in Adams County due to the growing interest in the sport.

The Zoom meeting held on April 14 had one attendee from the general public who did not make any comments, the in-person meeting on April 15th at Riverside Center had two attendees from the general public. There was much discussion regarding pickleball, and possible funding options for park improvements.

After reviewing the comments that were made by the public, a survey was created for the Planning Committee to determine if the comments that were received during the public comment period warranted a change to the proposed action register. The survey results indicated the need to move up the original timeframe to build additional pickleball courts and permanent restrooms at the county parks including Linn Grove and Limberlost Parks.

The public comment forms and the Planning Committee survey results can be found in Appendix C.

6.0 Action Register for Implementation

To help guide the implementation efforts to improve the DACPR system and help with park budgeting an action register was developed. The action register is divided into several different sections including "Existing Facilities", "Trails", "Programming", "New Amenities – short term", and "New Amenities – long term". Table 16 below shows the actions necessary to meet the needs and desires of the residents in Decatur and Adams County.

7.0 Plan Evaluation

The Park Plan is a living document that will need to be evaluated annually to determine the effectiveness of the action register, progress in addressing priorities, and if the public needs have changed over time. The Action Register of the Plan will be evaluated annually at the April meeting to measure progress in achieving the objections and actions outlined, as well as reassess the priorities given to each action. While all Park Board meetings are open to the public, the April meeting will have extra advertising via social media, website, and local newspapers to encourage public participation at the meeting.

8.0 Board Resolution Adopting 5-Year Master Park Plan

The Decatur Parks and Recreation Board, and the Adams County Parks and Recreation Board were given the opportunity to review the final draft of the Five-Year Master Park Plan. After review, the Board members had an open discussion of the final document. Each Board approved it as written either via email, or signed the Board Resolution to Adopt the 2021 – 2026 Decatur and Adams County Parks and Recreation: Five-Year Master Park Plan. 

Resurface Decatur trail

The public needs to be more aware of cleaning up after themselves when they use the park facilities.

Geneva's trail is well maintained and looks great! We rode our bikes on the Decatur trail and expected them to be nicer than Geneva's. The scenery was awesome but the asphalt itself needs a lot of work.

The pool is the best feature, yet you waste all the money on a baseball park. Put more money into the pool, the kids deserve it (so do the adults).

Do you offer projects to local Boy Scout troops? If you have any projects in the near future, I know there are boys with Troop 70 that are looking for an Eagle Scout Project.

It would be nice if there was a high school basketball league. My boys want to play for fun and high school sports is all about winning. Thanks for all you do for our communities!

I really think an indoor facility for practice would get great use! There are many teams that travel and pay to rent facilities in order to practice spring/summer sports in the winter. This was mentioned to the previous Mayor, but I was told the plans were already finalized for Hannah Nuttman and my suggestion fell on deaf ears.

The children's programs are phenomenal, and I wish there were more.

Ask council for more funds. They are doing well with what they have.

Check out Whicker Park in Bluffton. My kids love that place. I think it would be great for Decatur to add such a park.





Q3 There was interest expressed in creating more indoor pickleball courts. Should this be added to the action register?








